Upon completion, management determined that the full scope of the project, including the initial design phase, met the criteria for capitalization under U.S. GAAP. Accordingly, the \$16,000 previously expensed in fiscal year 2024 has been recorded as a capital asset. This resulted in an increase to net assets without donor restrictions and building improvements in FY25.

Other: Part X Column (A), Lines 23 and 24: A beginning-of-year balance of \$586,974 was reclassified from Line 24 to Line 23 to more properly reflect the nature of the amount. This reclassification has no impact on the organization's total liabilities or net assets.
